9.1 Course Fees: No documentation will be issued until we receive the Course Deposit. The course fees must be paid in full if documentation is required in support of a visa application. Students will not be permitted to start the course unless full payment has been received.

9.2 Cancellations & refunds:

Cancellation before arrival: The parent/guardian must inform the College in writing and return the student's Certificate of Registration. Cancellation fees are charged as follows, and any balance is refunded:

9.3 Changes to enrolments: We reserve the right to charge an administration fee of £50 / \$100 each time course details are changed after confirmation documents have been issued. This charge will not be applied to course extensions. Students from outside the EU entering the UK on a full student visa must pay the UK Visa Fee (£10) each time a change in dates is requested.

9.4 Visas: It is the responsibility of the parent or guardian to contact their local embassy (or other appropriate office) in good time, in order to obtain any visa/entry documents required for visiting the UK or USA. No visa support documentation will be issued until fees have been paid in full, and *our normal cancellation charges apply* if notification of a failed visa application is received less than 21 days before the course begins. If the visa refusal letter is received more than 21 days before the course begins, a full refund will be given (less UK Visa Fee (£10) if applicable).

9.5 Courses & course content: Courses are offered subject to demand. We reserve the right to vary the organisation and content of courses, and the range of leisure activities according to numbers of students, or in response to circumstances beyond our control.

9.6 Student conduct/standards of behaviour: We reserve the right to terminate without notice the course of any student who persistently misconducts himself/herself in their classes or accommodation, or who fails to meet the attendance requirements of the course. There is no refund of fees to students whose courses are terminated in this way.

9.7 Accident and medical Insurance/personal insurance: Every student must have a comprehensive insurance package before leaving home. This should cover loss of, and/or damage to personal belongings, medical expenses in the event that the student is ill, and course fees in the event of unexpected cancellation or curtailment of the course. AESTG Ltd., UK and St Giles Colleges Inc., USA accept no liability for the loss of, or damage to any person's property while on the premises of the summer school, or while engaged in leisure activities outside the campus.

9.8 Responsibilities of the parent/guardian: By signing the application form, the parent/guardian:

1. grants the student permission to participate in the full programme of classes and leisure activities;
2. authorises AESTG Ltd. (UK) / St Giles Colleges (USA) to take appropriate action in the event of any medical or other emergency, and accepts responsibility for the resultant costs;
3. accepts responsibility for any wilful damage caused by the student, and any resultant cost for repair or replacement

9.9 Optional activities: We reserve the right to cancel or to offer substitute activities on the optional activities programmes in the event of fewer than 10 students opting for any individual activity.

9.10 Breakages Deposit: Please note that a deposit of £60 (Nottingham, Oxford, Reading, Southampton), £120 (Kingston), \$100 (San Francisco Bay area) or equivalent sum in Euros is payable in **cash** upon arrival, and will be collected from all students on the first day of their course. The deposit will be returned to students with a deduction made for loss of keys and/or personal damage to any property of the school, or for any liability incurred by the school resulting from the individual student named on this form, or which is non-attributable to any individual student, but which can be reasonably held to be caused by students of the school (in the sole opinion of AESTG Ltd. (UK) / St Giles Colleges (USA)).

9.11 Adventure Tours: Booking and payment for Adventure Tours must be made **at least 8 weeks prior** to the start of the tour.

9.11.1 Please ensure that students requiring Schengen visas have these **arranged prior to booking** the Europe & Paris Disneyland Trip (through either the French or Belgium Embassy in your home country)

9.11.2 Adventure Tours finish at London Heathrow (UK) and San Francisco International (USA) at 06:00 on the final Sunday. Additional transfers from Heathrow to other UK airports can be arranged for a supplement of £50.

9.11.3 Students on Adventure Tours have a luggage allowance of one suitcase and small carry-on bag only (e.g. backpack). We are not able to provide storage for any additional luggage.

The UK camps are operated by AESTG Limited, which is a separate joint venture company owned by St Giles Schools of Languages Limited and the Anglo European School of English Limited, Bournemouth.

The US camp is operated by St Giles Colleges Incorporated, registered in the USA.
